- The applicant should provide all infrastructural facilities in terms of teaching and nonteaching staff, buildings, equipment and hospital facilities as per Medical Council of India
- I am further directed to inform that you and your institution are fully responsible to fulfill and 2. maintain norms including the infrastructure both physical and human resource, teaching faculty and clinical material, etc. throughout the academic year, as stipulated in Postgraduate Regulation of Medical Council of India. In case false/wrong declaration or fabricated documents have been used for procuring permission of the Board of Governors for the starting/increased intake and the said misconduct is brought to notice or comes to the knowledge of Medical Council of India at any stage during the current academic year, your institution is not liable to be considered for increased intake for the next academic year and this letter of permission for the increased intake/starting is also liable to be revoked for current academic year. Besides, Medical Council of India is entitled to take all such measures against you and your college/institution as permissible under the law.
- No student should be admitted in the above courses till the formal permission of the Board of 3. Governors is granted.
- The applicant should provide Bank Guarantee of required amount wherever required in 4. favour of Secretary, Medical Council of India, New Delhi valid for three years from a nationalized/scheduled Bank as per MCI's norms against increased intake/starting of above said course. However, Bank guarantee is not applicable for Government institution.
- 5. It may be noted that the Letter of Permission will not be issued if Bank Guarantee for required amount from a schedule bank is not submitted in order and within time. The Bank Guarantee submitted by the institute if not in order, will be returned.

- Postgraduate students admitted to this course would be required to present one poster presentation to read one paper at a national/state conference and to present one research paper which should be published/accepted for publication/sent for publication during the period of his Postgraduate studies so as to make him eligible to appear at the Postgraduate degree examination as prescribed in the Postgraduate Medical Education Regulations notified vide Gazette Notification dated 09/12/2009 (Clause 13.9).

As per Postgraduate Medical Education Regulations under Clause 14.(4)(a) it has been prescribed that "Every candidate shall carry out work on an assigned research project under the guidance of a recognized Post Graduate Teacher, the result of which shall be written up

The thesis shall be examined by a minimum of three examiners; one internal and two external examiners, who shall not be the examiners for Theory and Clinical examination. A candidate shall be allowed to appear for the Theory and Practical/Clinical examination only after the acceptance of the Thesis by the examiners." The Medical college while making admission to the course shall ensure that:-

- No admission is permitted beyond the sanctioned intake capacity. Selection of students to the Medical College is in accordance with the requirements ii.
- laid down in the Postgraduate Medical Education Regulations, 1997. No admission is permitted beyond the cutoff date prescribed in the Regulation for 111.

The Board of Governors reserve the right to withdraw/cancel/revoke the Letter of Intent/Letter of Permission if it comes to the notice that the permission has been obtained from Board of Governors by misrepresentation of fact or fraud.

It shall be incumbent upon the Medical College that the information relating to admission should be submitted within a fortnight of closure of admission to the Council. Any failure to submit the information within this time limit would be construed that the admission in the College were not in accordance with the statutory requirements, thereby enabling the Council to proceed in accordance with law against the college.

Action to grant formal permission of the Board of Governors for increased intake/starting of the said course at your college will be initiated on receipt of appropriate bank guarantee, if applicable and compliance letter fulfilling the conditions enumerated above. The acceptance letter may be sent immediately to enable the Board of Governors to issue Letter of Permission for the
