 - DURATION OF COURSE Two year (Four Semesters) 2.1 NAME OF STATUTORY /REGULATORY BODY :-Recommendation given by 5th Dean Committee Constituted by ICAR

3. ADMISSION

3.1 MODE OF ADMISSION-

Admission to the M.Sc. (Ag) Courses shall be mode on merit computed on the basis of marks obtained by candidate in a competitive examination called Post graduate entrance test for Agriculture to be conducted by the controller of examination of university.

- 3.2 ELIGIBILITY
 - (a) Candidate with four year B.Sc.-(Hons) Agriculture Degree under the guidelines of ICAR or equivalent qualification.
 - (b) Candidate with four years B.Sc. (Hort.) Degree under the guidelines of ICAR will be considered for M.Sc. (Ag.) Horticulture.
 - (c) Candidate appearing at the respective qualifying examination shall be eligible to appear at the entrance examinations but shall have to provide the proof of their passing the said examination by the date as decided by the university.
- 3.3 Number of Seats 10 per department
- 3.4 Supernumerary Admission-

A maximum of two (2) Supernumerary admission in each Department may be made from among the candidates who have been awarded fellowship by ICAR on the basis of written test provided they fulfill the minimum eligibility condition for admission such candidate shall not be required to appear in entrance test. 3.5 Admission of foreign nationals

As per university rules existing at the time of admission.

3.6 Scheme of Entrance examination.

The examination shall comprise one paper of 200 marks of two hours duration consisting of 120 multi choice questions.

3.7 Syllabus for the entrance examination

The questions paper shall be based on B.Sc.-(Hons) Agriculture courses generally through at graduation level as approved by ICAR.

- 3.8 Candidates will be selected in order of merit on the basis of the aggregate marks secured.
- 3.9 In all matters relation M.Sc. (Ag.) admission decision of admission committee shall be formal.
- 3.10 Scrutiny/re- valuation of the answer books of entrance examination shall be ----as per university rules.
- 3.11 The candidate short listed for counseling will be informed individually by post/email/university webpage.

4. ALLOCATION OF DISCIPLINES-

The successful candidate on merit basis will be called on on a specific dates for verification of certificates. Those format eligible shall be appear in order of merit on the given date & time before the Admission committee for counseling where they shall be asked to exercised shall be final & no change shall be allowed even if vacancies arise in any discipline at a later stage.

5. The M.Sc. Agriculture degree course shall be governed by the rules & recommendations of 5th Dean Committee constituted by ICAR

6.0 EXAMINATION

- (a) The examination shall be by Theory and practical including Sectionals, except in the case of Mathematics where the examination shall be by means of theory papers only.
- (b) Besides regular students and ex-students and subjects to their compliance with this.
- (c) Subjects offered at M.Sc. (Agriculture) Programme:

- 1. M.Sc. (Ag.) AGRICULTURE ECONOMICS
- 2. M.Sc. (Ag.) ANIMAL HUSBANDRY & DAIRY SCIENCE
- 3. M.Sc. (Ag.) HORTICULTURE
- 4. M.Sc. (Ag.) PLANT BREEDING D& GENETICS
- 5. M.Sc. (Ag.) AGRICULTURE CHEMISTRY & SILL SCIENCE
- 6. M.Sc. (Ag.) AGRICULTURE EXTENSION
- 7. M.Sc. (Ag.) AGRICULTURE ZOOLOGY & ENTOMOLOGY
- 8. M.Sc. (Ag.) AGRONOMY

Provided that the Board of Management of the University can add more subjects.

- (d) Any candidate who has passed the M.Sc. examination of this UNIVERSITY in any subject, shall be allowed to present himself for examination in any one or more of the optional papers in that subject not taken by him at the said examination and if, successful will be given a corticated to that effect. Provided that no candidate shall be allowed to offer more than two additional papers in any one year and in subject other than Mathematics, a candidate shall undergo a practical test in respect of the paper concerned.
- 7.0 ATTENDANCE:- Attendance in all classes (Lectures, tutorials ,laboratories ,etc) is compulsory. A student may be debarred from appearing at an examination on ground of unsatisfactory attendance.

Absence from classes without prior permission will be considered as an act of indiscipline.

8.0 Notwithstanding anything stated in this Ordinance, for any unforeseen issues arising, and not covered by this Ordinance, or in the event of differences of interpretation, the Vice-chancellor may take a decision after Obtaining, if necessary, the opinion/advice of a Committee consisting of any or all the Directors of Schools .The decision of the Vice- Chancellor shall be final.
